- (4) Will not create excessive additional requirements at public cost for public facilities and services and will not be detrimental to the economic welfare of the community and/or county.
- (5) Will comply with all applicable state, district, and County Ordinances and regulations.
- (6) Will not involve uses, activities, processes materials, equipment and conditions of operation that will be hazardous or detrimental to any persons, property or the general welfare by reason of excessive production of traffic, noise, smoke, fumes, glare or odors.
- (7) The demographic, social economic, fiscal and environmental impacts resulting from the conditional use to the population are minimized and found to be acceptable by the Commission following a public hearing.
- (8) Will meet an identifiable existing or future need or market.
- 6. Development Plan: A schematic plan of the proposed site for the conditional use showing the topography of the land, the major road plan, the proposed general area of each type of use and open space.
